FKF EMERGENCY GRANTS



The Emergency Fund Grant was created and is disbursed under the auspices of the Executive Committee. Any grant request up to \$2,000 to aid in the disaster recovery can now be disbursed immediately as long as the funds remain available.

Bridging the Generations Through Advocacy

Jack Levine – Founder, 4Generations Institute

As the child of an older father who lost his sight in his early 50's, my duties as his helpmate were to serve as his second set of eyes. At age seven or eight I began reading for him as well as leading him in unfamiliar locations.

My extended right arm was in his left hand's grasp as we walked, his chrome cane held in his extended right hand, tip tapping in a half circle. My step was slightly ahead of his not unlike taking the lead in a dance.

Sometimes in our home I played blind, with outstretched open hands, waving left to right, trying to imagine being in my Dad's shoes. Of course, I could at any point open my eyes to avoid a collision but I tried as I might to not do so in respect for my Dad's inability to see.

I can't help but believe that this blindness games was a formative to my profession as an advocate. In so many ways an advocate needs to see a bit ahead, to gauge the terrain and offer options for navigating policy.

Let's agree that many who serve in elective office are partially blind to the challenges their constituents face and often rely on trusted authentic voices to explain the intricate nuances of the problems people face, legal barriers, budget insufficiencies and other facets of needed system reform.

Surely their staff members play an important role, but the best leaders hire people who can identify experts, choose programs to visit, and build mutually beneficial relationships in producing progress.

An important part of a healthy democracy is effective advocacy, yet community voices often hesitate to act on issues requiring expertise in the public policy debate. Nonprofit civic service organizations have both the right and the responsibility to advocate on behalf of their causes, programs and the people they serve.

Because laws and customs restrain nonprofit organizations from full engagement in the traditional political arena, many nonprofits believe that they cannot engage in any public advocacy efforts to advance their ideas and agendas. That is not the case.

Community civic leaders and professionals in the family/social service, early childhood development, child protection, and health and education fields have a great opportunity to advocate within the rules of engagement without being thought of as lobbyists. Advocacy is both a right and responsibility of good citizenship.

There are safe and effective days to advocate. As Advocacy Chairman for the Florida District Kiwanis, I am conducting a series of divisional seminars and club meetings to educate fellow Kiwanians, nonprofit executives, professionals and volunteer leaders about techniques for effective advocacy. The presentation focuses on the 'rules of the road' for how to work with public officials, their staff members, the media and community supporters in a competitive arena.

I was honored to receive the Dr. W.J. Blechman Child Advocacy Award at the 2017 Florida District Kiwanis DCON. I am so thrilled to receive this cherished honor named for the distinguished Dr. Wil - child advocate extraordinaire and powerful force for good. My 20 plus year friendship with Dr. Wil has taught me so many lessons, but the most important one is simply this Know what you're talking about and take every opportunity to have your say. Advocacy is all about using our voices for good.

FOUNDATION GIFTS AT WORK

Ralph Davis Fellow

This Fellowship is an elite group of super dedicated Kiwanians and friends to Kiwanis that have either donated \$1000 or more to the endowment fund, or so moved others to contribute \$1000 or more in their name. Each Ralph Davis Fellow is given a serialized medallion to wear around their neck at Kiwanis functions, as well as a wall shadow box and a lapel pin.



Additional contributions are noted as Diamond Level Ralph Davis awards and are so noted by a change in the color of the neck ribbon and the issuance of jewel embedded pins denoting the Diamond Level. Occasionally, matching donation programs cover part of the contribution. The funds go directly into the Endowment Fund to insure a lasting legacy for the children. Income from the Endowment Fund is redistributed by way of grants to local clubs for project assistance.

Camp Kiwanis

Camp Kiwanis was opened after WWII as the fulfillment of a dream of Kiwanians Byron Craig, Miles Hiers, Jim Smith, Charlie Rogers, Wayne Millard and others to provide a camp environment for the youth of Marion County.

Over the past 70 years this spirit of "serving the children of the world" has provided over 30,000 youth with the opportunity to enjoy Camp Kiwanis for swimming, canoeing, archery, arts & crafts, field games, skits, dance and fellowship. Long lasting friendships and memories have been created during those weeks at camp. Sadly, in 2016, Camp Kiwanis lost one of its most passionate supporters, George Albright, Jr. Through the support of the community and the resolve of his wife Aggie Albright, a golf tournament has helped to support scholarships for local youth to continue to attend. In partnership with the KC of Ocala and the Florida Kiwanis Foundation, much needed repairs will now be taken care of so that future campers can enjoy the fellowship and fun in a safe environment.
